



Pharmacy Practice Residency Award

Sponsored by Pfizer Canada Inc.

Objective

The Pharmacy Practice Residency Award recognizes pharmacy practice residents whose major projects are judged to be most deserving in terms of significant innovation, practical application, or development in an institutional pharmacy practice setting.

Criteria

To be eligible, each candidate must:

- Be a current Member of CSHP as of **October 1** of the year of the residency program;
- Be enrolled in a CPRB-accredited pharmacy practice residency program in the province of the branch administering the award or have completed such a program within the previous year; and
- Submit an award application to the branch in the province in which the residency was completed. The residency project manuscript must be formatted according to the *Canadian Journal of Hospital Pharmacy's* (CJHP) [Author Guidelines](#).

Award

The Pharmacy Practice Residency Award consists of a **cheque for \$1,000 and an engraved memento**.

Each branch will be entitled to award one Pharmacy Practice Residency Award for every 10 pharmacy residents who are CSHP Members and who are enrolled in a CPRB-accredited program in the province.

Based on the 2018-2019 provincial distribution of pharmacy residents, and assuming all residents are CSHP Members, the number of awards that can be distributed by each branch is as follows:

Procedure

1. Each year, Pfizer Canada confirms its commitment to the Hospital Pharmacy Residency Award, which includes the monetary value of the awards, the cost of the engraved mementos, and a charge for the administration of the awards.
2. CSHP distributes the funds to the branch accounts and notifies the branches.
3. All participating branches advertise and administer the Pharmacy Practice Residency Award program annually within their respective branches.
4. Adjudication of submissions for the award is conducted at the branch level. Adjudicators are chosen by each branch administering the award. The branch provides evaluation forms to adjudicators.
5. Pharmacy Practice Residency Awards are presented at the branch level. Local Pfizer Canada representatives are invited to participate in the branch award presentations.
6. **By November 30** of each year, all branches forward the following information for the current year's Pharmacy Practice Residency Award program to the CSHP Awards Administrator (awards@cshp.pharmacy):
 - Name(s) of the winner(s)
 - Title(s) of the winning residency project(s)
7. CSHP orders the engraved mementos and forwards these either directly to award recipients or to a branch representative, according to the wishes of each branch.

8. CSHP and its branches recognize Pfizer Canada's support of this award in the following ways:
- All branches acknowledge the Pharmacy Practice Residency Award and its recipients in their respective newsletters.
 - CSHP includes the total value of this award in determining Pfizer Canada's sponsorship level.
 - CSHP recognize this year's award recipients in next April's eBulletin.
